

**GREATER VANCOUVER REGIONAL DISTRICT  
BYLAW NUMBER 1235, 2016**

A Bylaw to Amend Greater Vancouver Regional District Regional Board and Committee  
Remuneration Bylaw Number 1057, 2007

WHEREAS the Board of Directors of the Greater Vancouver Regional District has adopted "Greater Vancouver Regional District Regional Board and Committee Remuneration Bylaw Number 1057, 2007"; and

WHEREAS the Board of Directors of the Greater Vancouver Regional District wishes to amend "Greater Vancouver Regional District Regional Board and Committee Remuneration Bylaw Number 1057, 2007";

NOW THEREFORE the Board of Directors of the Greater Vancouver Regional District, in open meeting assembled, enacts as follows:

1. "Greater Vancouver Regional District Regional Board and Committee Remuneration Bylaw Number 1057, 2007" is hereby amended as follows:
  - a) In Section A (Whereas), by striking "794" and replacing with "226".
  - b) In Section 4 (Payment for Board and Committee Meetings and Other Attendances), by striking the term "select".
  - c) In Schedule A (Salary Remuneration), by striking "General Provisions, Sections 1 through 5" in its entirety and replacing it with the following Sections 1 through 6:

**General Provisions:**

- "1. The median of the gross salaries of the mayors in the GVRD will be determined every 4 years ("4 Year Cycle"). The first 4 Year Cycle will commence in the year 2016.
2. For year 1 of each 4 Year Cycle, the median gross salary will be calculated using information obtained from the previous year's *Statements of Financial Information* [RGH1] produced by each municipality in the GVRD pursuant to the *Financial Information Act* R.S.B.C. 1996 c. 140 and will include all of the mayors' remuneration including salary, any taxable benefits, the 1/3 non-taxable allowance and any transportation/vehicle allowance.
3. For year 2 of each 4 Year Cycle, the 12 month *Vancouver Consumer Price Index* for the preceding calendar year will be applied to the median gross salary calculated during year 1 of the 4 Year Cycle and the rates adjusted accordingly.
4. For year 3 of each 4 Year Cycle, the 12 month *Vancouver Consumer Price Index* for the preceding calendar year will be applied to the year 2 adjusted median gross salary and the rates adjusted accordingly.
5. For year 4 of each 4 Year Cycle, the 12 month *Vancouver Consumer Price Index* for the preceding calendar year will be applied to the year 3 adjusted median gross salary and the rates adjusted accordingly.
6. Rates established during any year will be retroactive to January 1 of that year."

d) In Schedule B (Remuneration for Attendance at Qualifying Meetings), section 1, by striking in its entirety and replacing it with the following:

1. Board chair and Board vice chair .5% of the Board chair's annual salary for:
- a) each meeting attended when serving on any select committee;
  - b) each meeting attended when ~~service~~<sup>ing</sup> on any standing committee, subject to an annual overall cap of 18 standing committee meetings; and twice that amount when a meeting lasts longer than 4 hours, subject to a daily cap of 1% of the Board chair's annual salary.

e) In Schedule C (Qualifying Meetings), section 8, by adding after the word "meetings" the words "or occasions".

f) In Schedule D (Payment of Expenses)" in Section 4 (Payment for expenses for Board members), by adding after the phrase "Payment for expenses for" the words "committee and".

2. This bylaw shall be cited as "Greater Vancouver Regional District Board and Committee Remuneration Amending Bylaw Number 1235, 2016".

READ A FIRST, SECOND AND THIRD TIME this 23 of September, 2016.
