- creating greater representation from First Nations on the Leadership Committee; and
- imploring the provincial government to reverse the decision to download the dikes and flood infrastructure onto local authorities and to take back the responsibility of diking and flood infrastructure with a system of local government and first nations input.

2022 UBCM Resolutions Related to Flood Resiliency

Several resolutions relating to flood resiliency were put forward and endorsed at the 2022 Union of British Columbia Municipalities (UBCM) convention that took place in Whistler from September 12 – 16, 2022 (Attachment 2). The resolutions included a call for the Province of British Columbia to significantly increase the level of funding and assume greater responsibility for flood preparedness and mitigation, including that the Province be re-established as diking authority in all local governments.

Vice-Chair Hodge was also an organizer of the panel for Lessons from an Atmospheric River: Insights for Local Governments held on September 15, 2022 at the UBCM Conference.

Lower Mainland Flood Management Strategy

A Fraser Basin Council summary and next steps for the Flood Management Strategy to September 21, 2022 is attached (Attachment 3). The Local Government Caucus of the Leadership Committee met on July 6, 2022 to discuss the Leadership Committee's terms of reference, First Nations participation and engagement, and options for completion of the LMFMS. The Leadership Committee was also scheduled to meet on October 21, 2022.

Build Back Better Together – July 14, 2022 Workshop

Vice-Chair Hodge and Director Hocking attended the July 14, 2022 Build Back Better Together full-day workshop organized by the Emergency Planning Secretariat.

Briefing from Fraser Basin Council to Metro Vancouver – September 21, 2022

Lower Mainland Flood Management Strategy (LMFMS or Flood Strategy)

- FBC supports, facilitates, and coordinates a collaborative initiative to reduce flood risk for communities throughout the Lower Mainland. Work in the current year has focused on:
 - Strengthening the LMFMS development process through the Leadership Committee, associated caucuses, and drafting a comprehensive Terms of Reference.
 - Comparing recently surveyed dike crest elevations with modelled water levels for the 20-, 50-, 100-, 200-year and 1894 Fraser River freshet floods. This information was sent to diking authorities to inform freshet preparedness and planning, and could also inform short, medium, and longer-term flood mitigation projects.
 - Implementing improvements to the regional flood model, including an updated software version, recent dike survey data, and refinements to the model mesh to improve accuracy.
 - Synthesizing the results of phase 1 and phase 2 LMFMS technical projects, regarding flood hazards, vulnerabilities, risks, and risk reduction; and how these findings can inform flood strategies.
 - Updating FloodWise.ca, including updates on the LMFMS process and related projects, as well as information on atmospheric rivers.
- The LMFMS Leadership Committee, which includes representatives from Metro Vancouver (Chair Dhaliwal, Director Hocking and Director Hodge), met on November 8, 2021, and February 7, 2022. The Local Government Caucus (Leadership Committee members representing local governments in the MVRD and Fraser Valley Regional District) met on July 6, 2022.
- The FBC staff team has presented regularly on the LMFMS at meetings of Metro Vancouver's Flood Resiliency Task Force (February, April, June, July), and participated in a field tour organized by the Task Force on June 29, 2022.
- Next steps are to:
 - Publish and disseminate a Synthesis of Technical Analysis report.
 - Convene the next meeting of the Leadership Committee, proposed for late October 2022.
 - Convene the next meeting of the Joint Program Committee (JPC), which includes staff from Metro Vancouver and member municipalities, proposed for late October.
 - Seek input from the Leadership Committee, JPC, and participating organizations to review and refine the draft comprehensive Terms of Reference.
 - Develop a regional scale "heat map" with overlays of information on the condition and height of flood protection dikes, seismic vulnerability of dikes, the relative magnitude of consequences of dike failures, and other related information.
 - Develop a Pathways to Action report, outlining issues where LMFMS engagement has revealed broad support, areas where further discussion and dialogue is required to clarify a common direction, and recommended pathways to resolve outstanding issues and move to action on flood risk reduction.
